# 1. Apologies

Apologies were received from Cllr. B. Stokes, County Councillors and Councillors D. White and A. Hurrell.

# 2. <u>Declarations of Interest</u> - None

# 3. <u>Minutes of the previous Meeting</u>

Agreed, with the following amendment:

<u>Broadband</u> - It was clarified that up to £75 subsidy towards installation costs will only be available to residents having fibre to the cabinet (FTTC) high speed broadband installed once BT Openreach has carried out the necessary work; it was suggested that this subsidy in the main be used to assist those on low income.

# 4. <u>Matters Arising from the Minutes</u>

<u>Beavers, Cubs and Scouts</u> – following discussions regarding assistance with the cost of hiring the village hall, the Leader has volunteered to talk on the work of these groups at the Parish Meeting on the 26<sup>th</sup> May and possibly help with refreshments – members warmly welcomed this information. # County Councillors and Borough Councillor – apologies received

**Temp. Community Warden (Nick Mayatt)** – has reported several incidents involving quad bikes, flytipping and a missing street sign. He has asked SWA to look one of their covers in Cormorant Road and has also noted several cars in the village with out of date tax discs (March 2010).

**PCSO** – did not attend – Clerk requested to see if she will submit a written report if she is unable to attend Parish Council meetings.

# 7. <u>Finance</u>

<u>Budget 2010/2011</u> – the draft budget was approved, with a few minor adjustments to fees and subscriptions.

Discussion took place regarding the Parish Council's continued fight to reclaim the £30,000 fraudulently taken by the previous Clerk. The present Clerk has been in discussion with the case officer located at Sittingbourne Police and the Financial Investigator based at Kent Police Headquarters in Maidstone. The delay is due to a second appearance at Maidstone Magistrates Court which has been held up by the Solicitors acting on both sides, and until this occurs the bank is exercising its right to withhold comment on its liability. It is now understood that the next Court hearing is in June and if the outcome is negative the Parish Council will pursue the matter through the Bank Ombudsman and consider engaging the services of a Solicitor to recoup this money from the previous Clerk.

Lamplighters – Reverend Webb attended the meeting and asked if the Parish Council could assist with the school hall hire costs for 2010/2011. Members agreed the donation of £380 – expenditure agreed under S19 1976LG(MP)A: the Parish Council's power to support recreational activity.

<u>KALC Subscription 2010/2011</u> – Members agreed the yearly subscription of £748.69p for KALC, the body that advises Parish Council on legal and other matters.

<u>Risk Assessments</u> – agreed to check with ROSPA as to whether a risk assessment is included in the yearly inspection of School Lane Playing Field – with a possible extra expenditure £20. <u>Action: Clerk</u>

<u>Localism in Action – NALC Conference and Exhibition</u> – this conference will look at local community bodies, like Parish Councils, undertaking more service delivery and representation and the enormous challenges that this will involve. Members agreed that Councillors Manning and Robb attend, at a total cost of £211.50p, which includes VAT which can be refunded.
