1. Apologies

Apologies received from Councillors. Hurrell, Menzies and Hyde; Borough Councillor B. Stokes; County Councillors M. Whiting and A. Willicomb and the PCSO.

2. Declarations of Interest

Cllr. Plumb declared an interest in Item 6 – Lamplighters.

3. Minutes of the Previous Meeting

Agreed by Members and signed by the Chairman as a true transcript.

4. Matters Arising from the Minutes

Fraud by Previous Clerk – Confiscation Enforcement Unit has confirmed that hopefully compensation money will be forthcoming in September.

6. <u>Visitors/Public Time</u>

Parishioners – Queried development affecting the use of School Lane Playing Field. The Chairman stated that it looks as though parishioners will be able to use this area until development commences, subject to a contract between the developers and the Parish Council.

Villagers asked if a dog waste bin could be located in Dunlin Walk. The area is still owned by the developers and Swale Borough Council cannot place their bins on private land.

County Councillors and Borough Councillor – apologies received; absent due to meetings.

Temp. Community Warden (Nick Mayatt) – report read out to Members; issues dealt with, including fly-tipping, litter in public areas, street lighting, etc. **PCSO** – apologies received.

7. Finance

School Holiday Club – Following receipt of further information, Members agreed to donate £595.30p to Iwade School to assist with the shortfall of money needed to run the Holiday Club. Expenditure agreed under S19 1976 LG(MP)A: the Parish Council's power to support recreational activity

Village Hall Car Park – no action at the present time as the Village Hall Committee is investigating various avenues of funding.

KALC Finance Conference, 25th September 2010 – Agreed Clerk and one Councillor to attend, at a total cost of £141 (includes V.A.T.)

Youth Club – Request for payments – Funding previously agreed by Parish Council; organisers now requesting payment for insurance - £146; KCC Youth Club affiliation fees - £75 and sundries, such as seating; games, etc. - £195.69p.

Lamp Columns – Clerk has received guideline quotes for replacing columns and disconnect/connection of electrical supply, with a view to gradually updating columns in the future.

Local Engagement Forum Grant – noted.

School Lane Playing Field Equipment – As new play equipment is proposed as part of the Section 106 Agreement for the Hillreed development; Members agreed that as they have expressed an interest the existing play equipment (with the exception of the Kick Walls and swings) will go to the School; the Kick Walls will be retained on the field; swings disposed of and benches relocated to hopefully a future allotment site.

Schedule of Assets – The Parish Council needs to obtain a valuation of the land it owns adjacent to the Village Hall for entry into the Fixed Asset Register. Clerk to contact Swale Borough Council to see if they can assist; if this is not possible it might mean engaging a Surveyor to carry out this work.

Lamplighters - Letter received from Reverend Webb informing that the group will no longer use the school for meetings, but have been successful in booking the Village Hall. He understands the school will refund the fees already paid in advance, for the period September 2010 to March, 2011 to the Parish Council.
