# 3.4 Planning Committee Meeting regarding section 106 land north of church

Meeting held on 6<sup>th</sup> December 2007 by the Parish Council Planning Committee. Meeting very productive. Cllr Phil Fearn had distributed a copy of minutes to all Councillors for consideration.

#### 3.5 Barn Refurbishment

The Clerk, Chairman and Vice Chairman met with a contractor at the site. The conclusion of the meeting was that the contractor was unable to give a satisfactory estimate on costing, until after Ward Homes made the Barn weatherproof and sound. It was agreed that this project would be put on hold until such time as Ward Homes complete the barn and the Parish Council were able to obtain accurate estimates. The current estimated costs are in the region of £20,000 to £25,000.

#### 4 Planning

The following members declared an interest: Cllr Brian Groves, Cllr Lisa Older and the Parish Clerk Mrs Sarah

Chairman advised the meeting that the Local Plan Review Inspectors Report is available on the Swale Borough Council website. The Chairman gave members a copy of pages 48-59 of Chapter 5, Area Action Plan Iwade

It advised the public that the presence of great crested newts had caused the Borough Council to reconsider two of its current housing allocation. Firstly the parcel of land to the north of the church and the allocation to the east of Woodpecker Drive, comprising part of an old orchard which also has nature conservation and biodiversity interest, especially with regard to great crested newts. The inspector considered that the most responsible and appropriate course of action is to safeguard the old Orchard from development, along with an appropriate area around it.

The development North of the Church is to go ahead.

#### 5. Business of the Council

## 5.1 Speed Watch in the Village

Community Police Officer Lindsay Woods advise the Parish Council that she had spoken to Warren Jarvis who deals with criminal damage, speeding vehicles, off road bikes etc and he was looking to set up projects around Kent but need the community to be involved.

It requires a minimum of 6 volunteers to assist and a fund of £2,000, then the community is set up with tripods which read vehicle number plates etc, the computer then reads the speed. The aim of this project is to have more number plates and camera pictures of these offenders.

Warren Jarvis will come to the January 2008 Parish Council meeting to discuss this project in more detail.
