5.2 Swale Borough Council Lighting Grant

Quote from letter dated 18.12.07, from Chief Accountant, Swale BC Financial Services.

Of the 36 parishes in Swale half have some footway lighting provision funded by Swale. Will you therefore bring it to the attention of your councillors that the funding of footway lighting may be withdrawn or reduced to a standard level based on an agreed formula. At the moment no firm decision has been made but I anticipate a recommendation coming forward as part of the Budget Report in February 2008 to be effective for the financial year 2009/10. However, there may be a proposal to cap lighting costs payments in 2008/09 to a maximum of the 2007/08 grant level This will mean that any actual cost incurred above this capped level has to be met by the parish council. I will obviously let you know as soon as a decision has been made to give you the maximum time to consider the implications for your council.

Since 1974 the IPC and a number of other PC's have received an annual grant to cover cost of lighting and repairs. However, our Current Parish Precept Letter states that because of financial difficulties caused by the Government the Swale BC intends to make the rural residents pay a discriminatory Council Tax for lighting.

It was agreed that Iwade Parish council would ask the Financial Services Committee to reconsider and reverse any decision they have made to 'withdraw or reduce' The Footway

[street] Lighting Grant given to the Parish Councils. Such an additional council tax on rural resident Parish Council felt would be a discriminatory tax.
