2. Confirmation of Minutes

3. Matters Arising from the minutes

3.1 Cllr Sue Dowling

3.2 Village Park 106 Agreements dated January 2001 and February 2005

The Chairman reminded members at the last Parish Council meeting Borough Councillor Ben Stokes advised the Parish Council that the Village Park land between Church Mews and Woodpecker Drive would be handed over to Swale Borough Council by the end of June 2007. Chairman had spoken to the legal Department of Swale Borough Council who are awaiting documents from Wards Homes solicitors.

3.3 Grade 2 Listed Barn

Cllr Lisa Older gave a report from the working party on fundings and proposals for the grade 2 listed barn. From the findings of the working party it was agreed that Cllr Phil Fearn will arrange another meeting with the Village Hall Committee, Parochial Church Council and Parish Council Planning Committee to discuss the next steps to take.
