2. Confirmation of Minutes

The minutes of the monthly Parish Council meeting held on 14th August 2007 were signed by Cllr John White who had been acting Chairman at that meeting.

Chairman Peter Wilks thanked Cllr John White for stepping in and taking the August Parish Council meeting.

Matters arising from the minutes

3.1 Land promised to the village under section 106 agreements.

The Chairman confirmed that all Parish Councillors had received copies of his report giving details of developers 106 agreements with KCC and Swale Borough Council. The report listed each agreement giving dates and covenants covering the transfer of the village park land to Swale Borough Council

In general terms all the Agreements pay money per house towards, Education, Village Hall, Transport, and Village Park

Village Park

Agreement numbers 1 & 2. Have a small scale Plan of the Village Park outlined in green 'For Identification only' it includes the cemetery land. The narrative says that there will be a proportionate contribution to the maintenance of the Village Park.

- 3. Plan 2, the whole area of the Village Park is shown edged red but again Page 8 states this is for identification purposes only. However, para. 8.1 states: The Developer covenants to transfer the part of the Village Park edged red on Plan No 2 to the Council...within 28 working days of the issue of permission [the Red area excludes the playarea)
- **4. Identifies the area bounded by the Church Mews houses** and the stream, edged in green as Village Park. But states in the narrative that it is for identification only, however, in para 7: Developer covenants to pay maintenance.
- **5.** Plan shows extra piece of VP land south and west of cemetery land. Para 6: The Developer covenants to transfer the Land within 9 months of occupation of 65th Dwelling (Grovehurst Development).

After the Chairman went through his report it was agreed that a letter from the Clerk would be sent to the Borough Solicitor, Mr Duncan Milne expressing the Parish Councils deep concern that the park area and other section 106's had not been handed over.

3.2 Planning Application SW/06/1355 AJJ

Wards Homes submitted a preliminary Bat and Barn Owl survey. The Chairman confirmed that the Parish Council members had received his draft objection regarding the above planning application. The objection is due to the revised details of the Bat and Owl Survey of this area. The objection asked the Council to delay the planning permission until the local plan inspector reports his findings. The new Local Plan is expected at the end of the year. Members were in agreement.

3.3 Grade 2 listed Barn Meeting

Parish Councillors had been unable to attend this meeting and it was agreed by the Village Hall Committee and Parochial Church to wait until the outcome of the planning application of the land north of the church.

3.4 Wireless CCTV presentation on 20th August

Parish Councillors were unable to attend this meeting. No update available.

3.5 Village Centre

Clerk advised Councillors, that retrospective planning applications had been submitted to Swale Borough Council.

5.4 Report of panel on SE Plan

Examination in Public took place in November 2006 to March 2007 – Report now issued which showed a modest increase in Swale Housing
