As part of our celebrations for our 80th birthday year, Members have been treated to a Designer Day at the WI's Denman College in May thanks to fund raising efforts and generous grants from the Parish and Borough Councils. Denman College www.denman.org.uk is the WI's centre for learning – imparting knowledge and practical experience in the fields of cookery, art, craft, wellbeing and lifestyle. The college offers a wealth of opportunities to learn new skills on one day schools and short courses. Everyone is welcome - men and women, members and non-members. They can even cater for groups of friends or hen parties that are looking for something a bit different. The college is set in the picturesque village of Marcham near Oxford. The Georgian mansion and 17 acres of grounds provide a relaxing environment for learning and the suite of rooms that make up the Studios provide comprehensive facilities for courses.

The East Kent Federation of WI's is taking over Denman College for 5 days in late May for East Kent WI's offering a range of topics to learn about. Some members from Iwade are participating in this Denman holiday, each of us having chosen a different course to follow from those offered.

Our Designer Day was a taster really. After coffee on arrival, we were treated to Magic of the Musicals when James Mitchell took us through the history of the musical. He rounded up the 2 hour session with a medley of songs, sung to us live, straw hat and all. We then had lunch in our own separate dining room with the opportunity to visit the Denman gift shop before the afternoon session with chef Peter Lien. Peter demonstrated how to cook 5 easy suppers, my favourite of which was Breast of Chicken with Oloroso, Dates and Almonds. Gorgoeus! As each dish was completed it was served up for us to taste. We were treated to afternoon tea and cake before the coach collected us and got us home soon after 6pm. I have to say Denman was extremely well organised, a very slick operation in a homely and stately setting. A lot was fitted into a short day.

Our monthly WI meeting in May at the village hall was about discussing and voting on whether the National Federation of WI's should pursue as a campaign a Resolution calling on the government to increase investment in the training, employment and retention of midwives to ensure services are adequately resourced and are able to deliver a high standard of care. There are chronic shortages of midwives and it is hoped that together WI members can use their collective voice to highlight the issue which touches the lives of many women and their families.

Our next meeting, 20 June, sees us welcoming Elizabeth Fagg-Shuttlewood to



the village hall with her talk about Book and Paper Conservation, Cleaning and Repair. Elizabeth has been recommended to us from another WI who went so far to say she was one of the best and most entertaining speakers they had ever had. We will be asking her to judge our competition for a favourite old book/document.

Parish Council Notes

Matters Arising from the Minutes

Village Park/Pond – Cllr. Hunt advised that a survey is being carried out on the pond to see what wildlife it contains. The new Iwade Nature Conservation Group has been set up and has seven members. It is hoped that at the time when KRAG carries out its Great Crested Newt survey in April these members will be trained in managing the Newts' environment. He also mentioned the possibility that a Villager will be donating £50 to help with this. **Queen's Diamond Jubilee Trees/Celebration** – The planting of the commemorative trees will be deferred until October, following advice received from the Nursery that owing to the drought the trees will not survive

Iwade Medical Centre – The Clerk has written to the PCT and the Medical Centre's Practice Manager, looking to set up a meeting to discuss some of the concerns raised by Parishioners.

Clerk added that she has now received notification from the PCT that a letter has been sent to all patients advising that a walk in session has been arranged at the medical centre on the 19th April, from 5.30 to 7.00 p.m. This session will allow patients to put forward their concerns and for the PCT to update them on the current position regarding the centre.

Replacement of old Parish Lighting – Agreed Cllr. Phillips to inspect all 26 columns and report back with his findings to the next meeting.

D.S. Smith Paper Limited – Following this company's offer of financial assistance/help with community projects at last months meeting, Members' were asked to formulate ideas to put forward. One idea is ask the company to purchase a pond dipping station and to help with the nature trail; it was agreed that Cllrs. Phillips and Hunt put together a presentation involving these suggestions for submission to the company.

Visitors/Public Time

Parishioners – Steve Theobald, who has taken over the running of the Village Market, sought clarification on restrictions for cooking in the Village Hall garden area; he would like to bring in more products which might require cooking on site. Members agreed to this proposal providing that risk assessments are carried out on each stall holder who wishes to take up this option and a copy of the assessment given to the Parish Council; stall holders have up to date Public Liability Insurance and adequate fire extinguishers are located around the site. **County Councillor and Borough Councillors** – Borough Cllr. Alan Willicombe thought the grant he had offered of £1000 was going through; Clerk confirmed she had submitted the forms to KCC and the Parish Council hopes to purchase a picnic table/seating and a bench for the Village Park, plus a bench for the green adjacent to Sheerstone.

County Cllr. Mike Whiting has arranged for bollards to be installed on the footway in the Village Centre's access road, to stop vehicles parking on the pavement. He is also pushing KCC for a 20 m.p.h. speed limit in Iwade. He informed that at a recent meeting of the L.E.F. teenagers had asked for a Skateboard Park in Sittingbourne. Swale Borough Council is looking for a site and the Clerk will write to the owner of the Speedway Track at Raspberry Hill to ascertain whether it is possible to use some of his land.

<u>Finance</u>

Seed of Hope Upkeep – The Chairman advised that during a recent discussion with Hillreed Homes it had been discovered that no-one has responsibility for maintenance of this work of art, which is now showing signs of wear and tear. Clerk instructed to contact the Sculptor, Will Glanfield, to gain his advice on the repairs.

Picnic Table and Benches (KCC Grant) – Clerk advised that she has pursued Borough Councillor Alan Willicombe's offer of a KCC grant. The total cost of the extended picnic table and two benches, excluding V.A.T., is £857. On top of this there is a possible £2,000 for concrete bases for each piece of equipment; this amount is a very quick 'guestimate' supplied by the Handyman, as there was insufficient time to obtain an accurate figure because of the short closing date for submission of applications.

Swale RAHM (Core Strategy)

Cllr. Gregory and Cllr. Phillips attended a meeting at Bobbing Village Hall on the 25th March, which was held to raise awareness around the new 20 year plan, which was offered for consultation. CPRE raised serious concerns around sustainability; there is a lack of schools, hospitals and highways to support the planned new housing. The Parish Council also needs to respond to the consultation, which includes Gypsy and Traveller pitch number options, the Council's 2010/11 Strategic Housing Land Availability Assessment and The Core Strategy Sustainability Appraisal.

Village Hall Updates

Peter Lovelock, Chairman of the Village Hall Committee, was invited to update the Council on this item. Peter attended the meeting of Swale Borough Council's Planning Committee on the 29th March, to hear the debate on the outline planning application for the Village Hall site. All fourteen Members present voted unanimously to agree the permission. However, after the meeting an e-mail was received from the Planning Officer advising that permission was subject to the view of Sports England, which was still awaited, and that they had until the 21st April to respond.

Provisions For Teenagers

Youth Parish Council – regrettably no teenagers attended the meeting to follow up their enquiry. County Cllr. Whiting was very interested in the formation of a Youth Council and the Clerk will advise him if there is any take up.

Skateboard Park – possible site Raspberry Hill – regrettably no teenagers attended the meeting. See Cllr. Mike Whiting's comments under Section 5 -Visitor/Public Time.

The next Parish Council meeting will be on Wednesday 13th June 7.30 p.m.

Due to growing number of complaints and the fact that Dog fouling is a nuisance and can also be a danger, particularly to young children, as it can lead to serious illnesses such as Toxocara, Iwade Parish Council would like to draw the following order to Parishioners' attention.

The Fouling of Land by Dogs (Swale) Order 2007 THE CLEAN NEIGHBOURHOODS AND ENVIRONMENT ACT 2005 The Dog Control Orders (Prescribed Offences and Penalties, etc.) Regulations 2006 (SI2006/1059)

Swale Borough Council (in this order called "the Council) makes the following Order:

This Order comes into force on the 7th day of January 2008
This Order applies to land specified in Schedule 1

Offence

(3)(1) If a dog defecates at any time on land to which this Order applies and a person who is in charge of the dog at that time fails to remove the faeces from the land forthwith, that personal shall be guilty of an offence unless-

- (a) He has a reasonable excuse for failing to do so; or
- (b) The owner, occupier or other person or authority having control of the land has consented (generally or specifically) to his failing to do so.
- (2) Nothing in this article applies to a person who-
- (a) Is registered as a blind person in a register compiled under section 29 of the national Assistance Act 1948; or
- (b) Has a disability which affects his mobility, manual dexterity, physical coordination or ability to lift, carry or otherwise move everyday objects, in respect of a dog trained by a prescribed charity and upon which he relies for assistance.
- (3) For the purposes of this article-
- (a) A person who habitually has a dog in his possession shall be taken to be in charge of the dog at any time unless at that time some other person is in charge of the dog;
- (b) Placing the faeces in a receptacle on the land which is provided for the purpose, or for the disposal of waste, shall be a sufficient removal from the land;
- (c) Being unaware of the defecation (whether by reason of not being in the vicinity or otherwise), or not having a device for or other suitable means of removing the faeces shall not be a reasonable excuse for failing to remove the faeces;
- (d) Each of the following is a "prescribed charity"-
 - (i) Dogs for the Disabled (registered charity number 700454)
 - (ii) Support Dogs (registered charity number 1088281)
 - (iii) Canine Partners for Independence (registered charity number 803680

Penalty

(4) A person who is guilty of an offence under article 3 shall be issued with a fixed penalty notice as prescribed by Section 59 of the Clean Neighbourhoods and Environment Act 2005. The amount of the penalty is £80 (or £60 if paid within 7 days). Failure to pay the fixed penalty will result in prosecution.

SCHEDULE 1

This Order applies to all land which is within the administrative area of Swale Borough and which is-

- (i) Open to the air and to which the public are entitled or permitted to have access (with or without payment). (Any land that is covered shall be treated as land that is 'open to the air' if it is open to the air on at least one side).
- (ii) Any clearly defined made up pathway that is surfaced by tarmac, gravel, shingle or concrete and any groomed grass area beside said pathway

Dear Resident

Following engagement with the local community, Kent Police have been asked to dedicate more time in dealing with issues of inconsiderate, illegal, and dangerous parking.

From speaking to motorists, it is often the case that many offences are being caused from a lack of knowledge rather than any criminal intent.

Can I please point out that if you park on the kerb and you obstruct access to the footpath sufficiently to cause a member of the public with a double buggy to walk in the road, or park in such a way as to obstruct the view of the junction then this would constitute an offence of obstruction.

The Highways Act 1980, Section 137(1) states:-

"If a person, without lawful authority or excuse, in any way wilfully obstructs the free passage along a highway he is guilty of an offence".

THE PENALTY FOR THIS OFFENCE IS A £30 FINE

Vehicle Numbers will be taken and repeat offenders will be given a ticket.

We will continue to monitor the problem and would welcome your continued support in the local area to deal with this community priority.
