1. Welcome and Apologies

2. **Declarations of Interest and Dispensations**

3. **Minutes of the Previous Meeting**

- 3. Community Warden/PCSO Community Warden written report: Reported a number of tyres in Old Ferry Road and fly tipping in same area to Swale Borough Council. Talked to Swale Borough Council about parking problems in School Lane; traffic team to attend. Resident complained about noise from youths evenings and nights at the new bus shelter in Ferry Road, advised them to gather information and forward it to the police on contact 101 when these incidents take place.

The new PCSO, Lee Fennell, introduced himself; he hopes to attend as many meetings as his shifts permit. Been a PCSO for 13 years, likes to be visible and will be seen walking around the village. Has received various reports of 'drifting' and patrols have attended. Reports of youths congregating around the bus shelters near Woodpecker Park; has spoken to them and not been any incidents since.

5. **Matters Arising from the Minutes**

- 1. Dark Nights = Double the Dog Poo Dog Warden is patrolling each Monday, checking on this and spraying any faeces. Each week a different colour is used which enables a count to see if there has been a decrease in incidents. Clerk to ask Warden to look at School Lane Playing Field, Woodpecker and the Space Park, areas hit by fouling. Action: Clerk
- 2. Speeding and Speed Watch Clerk to send details to Cllr. Dollimore; Council to look at resurrecting the Speed Watch team. Action: Cllr Dollimore/Clerk
- 3. Street Lighting Grovehurst Road (footpath and Vegetation) Response from KC received; they do not think the path and vegetation needs work. Cllr. Mills to take photos of the problem area and send to the Clerk for forwarding on to KKC. Action: Cllr Mills/Clerk
- 4. Shrub Bed Damage, Kingfisher Close Highways Inspector has looked at the area and will not be taking any action.
