MINUTES OF THE MONTHLY PARISH COUNCIL MEETING

1. Welcome and Apologies

The Chair welcomed everyone to the meeting; apologies received from Parish Cllr. Boniface; County Cllr. Whiting, Borough Cllr. Woodford and the PCSO.

2. <u>Declarations of Interest and Dispensations</u> - None

3. <u>Minutes of the Previous Meeting</u>

Proposed by Cllr. Dollimore and seconded by Cllr. Whiting, the Minutes of the Parish meeting held on the 9 October 2019 were agreed and signed as a true transcript.

4. Visitors/Public Time

- 1. **Visitors** A resident attended to express his concern that visitors/staff entering/exiting the School gateway in School Lane were narrowly missing children/adults. He stated that it is still a public footpath and as such pedestrians have the right of way. Community Warden/Clerk to take this up with the School. Clerk to ask County Cllr. Whiting for his views on this.

- 2. **County and Borough Councillors** County Cllr. Whiting written report received he updated again on SGN and the gas main replacement work/programme along the A2.
- 3. **Community Warden/PCSO** the Community Warden met with Jo Jury, Youth Outreach Worker to discuss ideas for youths in Iwade. Has been going into the School and working with children; he will be talking about road safety. He is looking at anti-social behaviour and is working with Kent Police (one idea is a football programme) and asked if anyone from the Parish Council is willing to work with him on this, Cllr. Clark volunteered.

The PCSO sent written report – Break-in to a container on a property on Grovehurst Road – crime report taken. Nuisance vehicles reported around Knauf, drifting on roundabout – patrol attended 20 mins later, but no vehicles seen. Report of nuisance youths in and around Swallow Avenue – patrol attended but did not find anyone. Reports of youths in other parts of Iwade using foul language on occasion and generally causing a nuisance – the PCSO is liaising with the Warden and the Youth Engagement Officer concerning this. Some of the youths come from the village, but others are from outside. Some offenders have been positively identified, so home visits will follow. 'Tiny' bag of Marijuana found on the nature trail path – informant disposed of it in a nearby bin. Vehicle stolen overnight from pub car park and another from road off School Lane – crime reports taken.

5. Matters Arising from the Minutes

1. **Drains, School Lane – County Cllr. M. Whiting** – Still no response from County Cllr Whiting; Clerk to approach a contact at KCC. Bring back to next meeting. *Action: Clerk*

2. **Parish Councillor Vacancies** – Closing date has now passed, and no candidates have come forward. Clerk advised that if known suitable candidates can now be invited on to the Parish Council.

6. Planning

1. **19/505108/FULL:** Iwade County Primary School, School Lane Iwade Sittingbourne Kent: Erection of a single storey extension within existing courtyard to form a new hall – agreed to respond that Iwade Parish Council objects to this application and has the following serious concerns:

Has ventilation been considered? There is no mention in the D&A as to how the rooms will be ventilated. Has a ventilation strategy been developed? Councillors understand there has to be a minimum level of natural ventilation; if it is windy or rainy, how will the rooms be naturally ventilated?

Has a light analysis been undertaken on the classrooms? Looking at the plans, the two classrooms with no courtyard access will be dark.

Means of escape: if there is a fire in the corridor pupils are stuck. There is an inner room situation going on which we understand doesn't comply with Part B of the Building Regulations. Fire escape is seriously compromised with this infill.

2. **19/505215/FULL:** Erection of 14 bungalows and chalet bungalows, which will provide age-restricted general market accommodation for those over the age of 55, together with 21 communal car park spaces and amenity space: Land Off Sheppey Way Iwade Kent – Agreed to respond that Iwade Parish Council fully supports this application and is pleased to see bungalows being provided for the elderly residents who might wish to stay within the village.

However, there is one area of concern - it is noted that the surface water will go into the Iwade stream. Several applications have done this in recent years, adding to the watercourse. In May last year there was serious flooding within the village, which KCC, the Environment Agency and Swale Borough Council are aware of and the National Flood Forum became involved as residents suffered loss of property. With the increase of incidents (possibly due to climate change) of flooding and with the history of Iwade Stream the Parish Council would ask that alternative methods of drainage be looked at to deal with surface water.
